

# LIMITED ROOF TRUSS, FLOOR TRUSS AND WALL PANEL WARRANTY

Edson Truss (hereafter referred to as the "Warrantor") guarantees that the workmanship of our roof trusses, floor trusses and wall panels are free from material and production defects. Upon delivery of said manufactured products to the jobsite, it is essential that the purchaser and/or a representative of the purchaser inspect all items and note discrepancies or damage should any exist.

To register your warranty, the purchaser must:

- Complete and send the attached Warranty Registration Form
- Send a copy of the signed, complete Bill of Lading with any discrepancies noted
- Send photos of material discrepancies / damages should they exist

The Warrantor's warranty for roof trusses, floor trusses and wall panels is valid only for the intended application in which the manufactured product is used, and when stored, handled and installed in accordance with acceptable building practices, applicable building code, conditions/specifications indicated on pertinent design drawings and layouts, industry accepted standards, and the Warrantor's installation requirements/guide. This warranty only applies to roof trusses, floor trusses and wall panels which become structurally unacceptable due to mis-manufacture by the Warrantor.

This warranty does not cover claims resulting from any other factor, including but not limited to: physical mishandling/abuse, improper storage, improper installation or repair, modification of the material, acts of God, acts of war, acts of vandalism, acts of theft, vermin or insect infestation, or other chemical or biological factor.

Failure to follow restrictions, warning, guides, etc. supplied by the Warrantor and/or modifications/alterations to the manufactured product shall null and void the Warrantor's warranty obligation.

EDSON TRUSS DOES NOT MAKE ANY OTHER WARRANTY OF ANY TYPE, EXPRESS OR IMPLIED, IN RESPECT TO PRODUCTS; EDSON TRUSS SPECIFICALLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. EXCEPT FOR THE OBLIGATIONS SPECIFICALLY EXPRESSED IN THIS WARRANTY, IN NO EVENT SHALL EDSON TRUSS BE LIABLE FOR ANY DIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER BASED ON CONTRACT, TORT OR ANY OTHER LEGAL THEORY AND WHETHER ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
